MAYFLOWER DISPLAY TERMS & CONDITIONS

- $1. \ \ The \ Display \ is \ charged \ at \ the \ Display \ Rate \ above \ as \ per \ Mayflowers \ standard \ trading \ terms$
- 2. We require 5 times the turnover of the nett cost of the display in order to rebate the full cost (excludes Template and Fit costs)
- 3. The time to achieve the criteria of 5 times the qualifying turnover to achieve your rebated display is as follows:

Total costs of Displays	Time to achieve the turnover criteria
<£2499	6 months from invoice date
>£2500 <4999	9 months from invoice date
>£5000	12 months from invoice date

- 4. The criterion of 5 times the qualifying turnover is not negotiable and is the fixed rate.
- Maximum cost for each individual display = £2500 nett (ex VAT)
- Template and fit charges are not included in the agreement, although delivery charges are included.
- There must be an overall minimum of 12 months trading from the invoice date of the display, if the display is removed before this time the full amount is due.
- Approximate Turnover to be agreed with the Sales Manager for the 12 month period.
- $Qualifying\ products\ and\ colours\ include\ all\ existing\ products\ on\ sale\ (n.b.\ can\ be\ found\ in\ the\ Retail\ Price\ List)$
- $10. \quad \text{Authorisation of Display Request must be signed by the Retailer, Sales Manager \& Managing Director.} \\$
- 11. The Sales Manager will advise on colour options to avoid discontinued or out of stock colours.
- 12. This offer covers all Kitchen Worktop displays supplied by Mayflower subject to the qualifying criteria.
- 13. Displays must exhibit the small Brand logos as part of the display for example Silestone, Dekton etc.
- 14. The Customer Account must not be in arrears to qualify for this offer and any late payment of invoices will nullify any display agreement.
- 15. Template and Fit costs are chargeable to the customer, with no discounts given.
- 16. Mayflower reserves the right to terminate the offer at any time or disqualify any customer at their discretion and with no notice period.
